

Tiny Tots

Tiny Tots is an infant/toddler-based program designed to support growth, build self-esteem, and encourage communication skills with classes that build strength through play. SUBJECT: CONSIDERATION AND APPROVAL OF THE 2025 BAND PERFORMANCES FOR THE NIGHT MARKETS, FIREWORK FESTIVAL AND FOURTH OF JULY CELEBRATION

SUMMARY: Staff is requesting approval for the 2025 Night Markets, Firework Festival, and the Fourth of July Celebration band performances.

RECOMMENDED ACTION:

Staff recommend the Commission consider and approve the 2025 Night Markets, Firework Festival, and Fourth of July Celebration band performances.

FISCAL/FINANCIAL IMPACT: The 2025 City Special Events Calendar includes 10 Night Markets, from the total Night Markets 4 are include in the Fiscal Year (FY) 2024-25 special events budget and the remaining 6 will be proposed in FY 2025-26 budget deliberations.

The funding for the 2 Fourth of July Celebration events scheduled on July 3, 2025 and July 4, 2025, will be proposed in FY 24-25 budget deliberations.

The cost to host a live 2- hour band performance at a City event averages between \$1,600.00 to \$2,000.00. This amount includes the performer's providing the audio system with installation and management.

DISCUSSION: At the November 12, 2024 City Council Meeting, the City Council approved the City's 2025 Special Events Calendar which includes 10 Night Markets, the Firework Festival and the Fourth of July Celebration. The events are scheduled to feature a live 2-hour band performance in each respective event.

The live entertainment featured at these events encourage the public to bring out their lawn chairs to enjoy music or dance the night away while celebrating community, music, and the vibrant spirit that defines South El Monte in a safe and family friendly environment.

In efforts to engage the community, staff conducted a survey on the City's social media accounts requesting band recommendations for the City's upcoming events. The survey results have been listed and detailed in order based on the highest level of popularity in Attachment A, 2025 Band Survey Results.

Furthermore, staff compiled the survey results into a recommended list for the 2025 events referenced as Attachment B, 2025 City Event Band Recommendation List. To ensure the performer's availability on desired dates, staff is seeking City Council's direction and approval to proceed with scheduling the approved bands accordingly.
