1 CALL TO ORDER AND ROLL CALL:

Chairperson Hennings called the meeting to order at 6:02 p.m.

2 APPROVAL OF AGENDA AND WAIVER OF FULL READING:

A motion was made by Commissioner Figueroa, second by Commissioner (Yolanda) Del Rio and carried to approve as amended and waive full reading, motion was carried 6-0.

3 Presentations: None

4 PUBLIC COMMENTS:

Vice-Chairperson (Yolanda) Del Rio mentioned that she received a phone call from Mr. Tavera and notified her that his grandson's military Banner was up, but his name was misspelled. Miss Yanez stated that staff would take action to correct the banner immediately. Vice-Chairperson (Yolanda) Del Rio stated that she asked Mr. Tavera if was okay to leave the banner up for Memorial Day and have it fixed after. Mr. Tavera agreed to leave his grandson's banner up until then.

Commissioner Lopez asked who was getting the brackets for the banners. Miss Yanez stated that Mr. Ramos from maintenance is getting quotes for the brackets.

Commissioner Figueroa asked what were the three names of new banners and did the family pay for the banners. Vice-Chairperson stated that banners are being paid with funds from the patriotic account. It was mention that the coast of the banners was \$150 each. Miss Saucedo stated that banners were order for the following residents: Isaak A. Chavez. Rudy Alexander Lopez, and Eloy Jimenez.

5 APPROVAL OF MINUTES:

April 26, 2017

A motion was made by Vice-Chairperson Yolanda Del Rio, seconded by Commissioner Garcia to approve the above referenced minutes, motion was carried 6-0.

6 UNFINISHED BUSINESS:

a. Cinco De Mayo Fundraiser

Chairperson Hennings mentioned that the sales of the agua frescas went well. The following was raised at the Cinco de Mayo Celebration

\$ 30 opportunity drawing

Total \$254

Chairperson Hennings turned in the money to Miss Saucedo on Monday, May 8, 2017. Miss Saucedo deposited the money in the Patriotic account. Chairperson Hennings made a motion to have staff draft a letter to Mrs. Colin thanking her for making the agua frescas, loaning her equipment, and helping serve the drinks; motion was seconded by Commissioner (David) Del Rio, motion carried 6-0. Staff will email the letter to Chairperson. Vice-Chairperson stated that Mrs. Colin spent \$44 for the items to make the aguas, which was reimbursed.

b. Monument Wall

Chairperson Hennings stated that she received phone call from Mr. Ramos stated that the new plaque was placed on the Monument Wall. She stated that it looks beautiful and its Oxidized, however it was not done the military way, which is adding each veterans name individually on a small plaque. Commissioner (David) Del Rio stated that there are five plaques for each of the services, but the middle plaque has the names of the City Council and dignitaries. He stated that it should not be this this way because it was meant for people who serve in the military. Commissioner (David) Del Rio stated that they should have their names on different plaque, and placed on the right side next to the person that donated the Monument Wall. Chairperson Hennings would like to know where the budget stands at this time. Commissioner Figueroa stated the Monument Wall is to honor the men and women who served our Country. She stated

that it was wrong of the City Council to approve the project without asking the Patriotic Commission. Chairperson asked Miss Yanez if she could ask if the Monument Wall can be redone in the correct military style. A motion was made by Commissioner Lopez to have a separate plaque made with the City Council's names and have the Monument Wall changed to military style, Commissioner Figueroa seconded for discussion. Commissioner Figueroa asked what did Aldo, Vacco Industries, In Memory of Larry Beard do? Commissioner Figueroa asked if there is record of how they contribute to the monument wall.

Commissioner Figueroa made a motion to have plaque made with all the names of the City Council that were in at the time and the dignitaries, but remove former Mayor Aguiñaga's name from the plaque due to what has transpired, Commissioner Lopez seconded for discussion. Commissioner Lopez asked if Mr. Aguiñaga's name is removed from the plaque does that mean that his name will be removed from all the signs of projects that were approved under his term. Vice-Chairperson (Yolanda) Del Rio is opposed to have former Mayor's removed from the plaque because he supported the Street Military Banner Program. A vote was taken to have former Mayor's name removed.

Commissioner Garcia asked if the Patriotic Commission would be selling military items at the ceremony, if so he has someone who is willing to help with the table. Miss Yanez stated that there would be a BBQ in addition to the light refreshments after the ceremony.

Patriotic Commission Bylaws

Chairperson stated that with the change of staff, the bylaws were misplaced. Mrs. Yanez stated that she had staff call surrounding cities to see if they could share their bylaws with us, and they did not have a Patriotic Commission they have a committee therefore they do not have bylaws.
